

#### **Meet our CHIEF GUEST**

## Hon Manasseh Damukana Sogavare Minister of Finance and Treasury of Solomon Islands.



Hon. Sogavare holds a bachelor's degree in accounting and Economics from the University of the South Pacific (USP) and a Masters' Degree in Management Studies from the University of Waikato in New Zealand

Prior to his appointment as the Minister of Finance and Treasury, Hon. Sogavare was elected Prime Minister of Solomon Islands for the fourth time on 24 April 2019, following the national general election on 3rd April 2019.

Hon. Sogavare first held the Prime Ministerial post from June 2000 to December 2001, then again from April 2006 to December 2007, and prior to this election from November 2014 to November 2017.

Hon Sogavare's political career begun in 1997 when he won the East Choiseul Constituency seat in the 1997 national general elections. This is his seventh consecutive term as MP for the East Choiseul Constituency in Parliament.

From July 1998 to September 1999 he served as the Deputy Opposition Leader. During this period Hon. Sogavare successfully completed a Masters' Degree in Management Studies from Waikato University using flexible learning delivery.

Hon. Sogavare took over the leadership role of the Opposition party in January 2000 following the death of then Opposition Leader, the late Honourable Solomon Mamaloni and remained in this position until June 2000 when he became Prime Minister. He retained the Opposition Leader role from December 2007 to April 2010.

In the 9th Parliament, Hon Sogavare was a member of the Opposition under the leadership of Hon Steve Abana and later Hon Dr Derek Sikua and served as Chair of the Parliamentary Bills and Legislations Committee. The committee was notable for referring back to the government several legislations submitted to Parliament for approval for being poorly done.

#### Andrew Schloeffel Australian Deputy High Commissioner – Solomon Islands



Andrew Schloeffel is Australia's Deputy High Commissioner to Honiara. Prior to this role, he was Assistant Secretary Fiji and Vanuatu in DFAT's Office of the Pacific. Andrew has previously served overseas as Counsellor Economic at the Australian High Commission in Honiara (2018-2021) and in defence, private sector and World Bank roles based in Dili, Port Moresby, and Washington DC.

In Canberra, Andrew has worked on foreign and economic policy and international development issues at the Department of Defence, the Department of Resources Energy and Tourism, the Australian Agency for International Development and the Department of Foreign Affairs and Trade.

Andrew holds a First Class Honours Degree in Science from Monash University, a Master of Arts from the University of New South Wales and is a graduate of the Australian Command and Staff College.

## Prof. Andrew Conway FIPA FFA IPA Group CEO



As CEO, Andrew is responsible for the future of the Institute of Public Accountants and the Institute of Financial Accountants where he leads an international team that represents more than 50,000 members in more than 100 countries known as the IPA Group. Andrew helps small businesses around the world navigate complex social, environmental, and economic issues.

In 2023, the IPA was named Association of the Year by the Associations Forum for its commitment to professional excellence. He is a vocal mental health advocate, and co-founder of the multidisciplinary IPA-Deakin University SME Research Centre where he initiated the Counting on U wellbeing program to better support the small business community Andrew is a former Treasury chief of staff, and the youngest CEO of a public entity in Australian history. In 2001, he was awarded the Centenary of Federation Medal for his service to the community.

Andrew holds academic qualifications in education, commerce, and postgraduate qualifications in artificial intelligence from Deakin University. In 2016, he was presented with a Distinguished Fellow award from the Vice-Chancellor of Deakin University.

Andrew is also an honorary professor of accounting at Shanghai University of Finance and Economics, an adjunct professor at Deakin University, and an adjunct professor at Lanzhou University.

# Brian Blood Chief Executive, Confederation of Asian & Pacific Accountants (CAPA)



Brian has been Chief Executive since September 2009 and was previously with global Big 4 accounting firms for 27 years in the United Kingdom and Australia, including 16 years as a Partner. He commenced his career with Arthur Andersen in London, England and transferred to Sydney, Australia in 1985, later joining Ernst & Young.

As an audit partner he worked with many large, multinational corporations. In his last ten years as a partner, he worked increasingly with public sector clients, in both an audit and advisory capacity.

He is currently an independent chair or member on a number of Australian state-government audit and risk committees in planning, environment, transport, health and emergency services sectors. The entities are significant in size, some with over 10,000 employees or with assets worth billions of dollars. Brian was the President of CPA Australia in 2002. In 2003, he was honoured with a Centenary Medal for services to the accounting profession in Australia.

### Ms Lilly Lomulo Head of Talent Culture & Inclusion, British American Tobacco



Lilly currently holds the Head of Talent Culture and Inclusion at British American Tobacco (BAT) Solomon Islands, has dedicated over two decades to driving excellence in Talent Attraction, Development and Retention; Diversity, Inclusion, and Culture; and Building leadership.

Her efforts included significantly building line manager capabilities across Southeast Asia and placing accredited rewards for BAT in South Pacific. Under her leadership, BATSI earned accolades such as the Inclusion Diversity and Local Talent award from SICCI's Business Excellence Awards and attaining twice in a row the prestigious American based annual "Great Place to Work" certification for the years 2023 and 2024.

Before her current role, Lily held senior positions in various private organizations, in general management, accounting, and corporate and regulatory affairs.

Lily is deeply passionate about community support serving on several boards, including the Solomon Islands Chamber of Commerce, the Central Bank of Solomon Islands, and Trade Disputes Panel. Currently, she contributes her expertise as the board of director for State owned Solomon Power Ltd and NGO Solo Enviro.

Lilly is committed to developing young Solomon Islanders and focuses on fostering leadership skills and empowering women to build confidence, engage in decision-making processes, to contribute meaningfully to the nation's growth and hope that her profound impact on her industry and community underscores her dedication to creating an inclusive, dynamic, and forward-thinking talent in Solomon Islands.

## Mr Peter Vial New Zealand Head (Chartered Accountants of Australia and New Zealand)



Peter started his career as a tax consultant at KPMG and then spent time working as a paralegal overseas. Peter worked for New Zealand's Trade Development Board for 6 years, including 3 years as New Zealand's Trade Commissioner to Germany.He moved on to work at PwC for 12 years as a senior manager and then executive director.

Prior to joining CA ANZ in 2013, Peter was an Associate Professor in Commercial Law at Auckland University.

Before becoming New Zealand Country Head Peter was CA ANZ's New Zealand Tax Leader. He is a nationally recognised and respected authority in this area.

In his current role, Peter leads the New Zealand regulatory and professional conduct functions and has oversight of New Zealand governance and advocacy. He is a Fellow Chartered Accountant, a barrister and solicitor of the High Court of New Zealand and a Chartered Member of the New Zealand Institute of Directors.

### Prof. Philomena Leung

PhD, MAcc, PFIIA, Group Executive Education, Institute of Public Accountants (IPA group), Professor Emerita Macquarie University.



Philomena Leung is a Professor Emerita at Macquarie University and Group Executive Education at the Institute of Public Accountants (IPA). Before this appointment, Philomena has held multiple senior Professorial roles as Head and Associate Dean in Australia since 1990.

Philomena has developed and instigated different innovative educational and transdisciplinary programs, including, internal audit and risks, a multi-disciplinary cyber security hub, a think tank for the chairs of accounting and finance ANZ, and an innovative program for future skills through an Education 3.0 program, and pioneered accounting ethics education in Hong Kong and in Australia.

Philomena has published extensively in academic journals in the areas of auditing, ethics, governance, and accounting education and been the lead researcher commissioned to develop a model for ethics education in accounting for 160 countries under the auspices of the International Federation of Accountants (IFAC). In particular, Professor Leung has recently completed the first version of the Global Certificate of Public Accounting (GCPA) program for the IPA Group in collaboration with Incept Labs.

This world leading transdisciplinary accounting certification program uses a microcredential framework to create various new opportunities for accounting professionals working in the public interest and with a broad range of competencies. Philomena holds a PhD in accounting ethics (RMIT University), a Master of Accounting and Finance (Glasgow) and is board director for the Institute of Internal Auditors Australia. She is an expert panel chair of the Hong Kong Accreditation body for Academic and Vocational programs

## Motivational Speaker – Solomon Islands Sports Icon



Batram is the first ever local contracted with Solomon Islands Football federation (SIFF), as the current head coach for Women's National senior team. He was also appointed as the head coach for the under – 19 Men's youth level.

Batram is a well know household name and a good ambassador when it comes to football in the Solomon Islands and Pacific Islands. He played football since his high school days; he played for 22 years from 1990 – 2012. He played in countries like NZ, Tahiti, Fiji and Vanuatu.

As a player to high light few achievement, he played in the team that won the first ever Melanesian cup held here in Honiara, Solomon Islands in 1994; also as a player he is the captain of the team that drew 2-2 with Australia , Socceroos in 2004, and lastly vote as the 4th best player in the OFC.

As a coach he coach for 11 years; he coach in countries like, PNG, Fiji and Vanuatu. He led women's national senior team (WNT) to improve their standing in the OFC/FIFA rankings. WNT won bronze, Silver for the 1st time in history in any tournaments under OFC. He also led U-19 to win against U-17 Australia in their first friendly match here in SI for the first time.

He is described as a history maker. In Nelson suburbs, NZ they described him as rain maker

Luke Forau is the Governor of the Central Bank of Solomon Islands (CBSI). He was appointed Governor on the 1st October 2019. Before that, he was the Deputy Governor for a year, and prior to that position, was the Advisor to the Governor's Office from 2016 to 17th September 2018.

He also held the position of Chief Manager Economics, Research & Statistics Department.Mr Forau has been with the Central Bank since January 1999. He holds a Doctor in Philosophy (PhD) in the field of Economics from the University of New South Wales, a Master Degree in International and Development Economics from the Australian National University, and a Bachelor of Arts Degree in Management and Public Administration and Economics from the University of South Pacific.
